

### 82/25 Apologies for Absence

None received.

### 8325 Declarations of Interests

Cllr Williams declared a personal interest in agenda item 7 (Third prison).

### 84/25 Minutes of the Meeting held on 13 October 2025

Resolved: the Minutes (as circulated) were approved and signed by the Chairman as a correct record.

### 85/25 Residents Surgery

A vehicle accident on Southport Road, resulting in severe damage to a parked car was reported.

The swings on Wymott Park have not yet been replaced.

A representative of the Peter Lathom Charity requested assistance with identifying residents who may be in need of financial help from the charity.

### 86/25 Planning Matters

25/00977/PIP Permission in principle application for the replacement of stables with 1no. detached dwelling at Land at South Side of Pumphouse Lane

25/00979/TPO The trees under the TPO are constantly being hit by passing wagons and causing debris in the garden and on the road. Concerned it may cause a RTA Application for work to protected trees - Chorley BC TPO 2 (Ulnes Walton) 2001; T1-T4 Sycamores. Crown raise to 5.5m at Stockbridge Barn Ulnes Walton Lane

25/01060/NOT Notice of intention to install 3no. 9m light wooden poles and 2no. 10m light wooden poles for the provision of fixed line broadband apparatus at Willow Road/Pump House Lane

There were no objections to these applications.

25/00901/PIP Permission in principle application for the erection of up to 6 dwellings and associated development at Land Adjacent to The Poppies, Southport Road. Concerns regarding the area being subject to flooding were raised.

Application 25/00966/FUL Erection of wastewater pumping station to replace existing, and demolition of barn at Pump House Lane, Wymott. Concerns regarding HGV access to the site were raised and a request to consider the use of an alternative access via Ridley Lane is to be submitted.

25/01039/DIS Application to discharge condition 27 (mitigation strategy for barn owls) attached to planning permission 21/01028/OUTMAJ on land adjacent to HMP Garth and HMP Wymott. Some of the information provided is to be queried. The location specified for the Owl box is around 400-500m away from the location described as Ridley Lane. The track off which the tree is located is unnamed. Also concerns regarding the owl box being attached to an Ash tree, which are susceptible to Ash dieback. A suggestion to use a more suitable tree is to be submitted.

## 88/25 Third Prison

Councillors provided suggestions for items to be raised at the inaugural Stakeholder Group Meeting, called by the Ministry of Justice. Suggestions included a requirement for passing places for vehicles and a reduction in the speed limit along Ulnes Walton Lane, a mini roundabout at the Moss Lane/Ulnes Walton Lane junction and to query road dimensions provided by MoJ consultants, which were discredited by the Planning Inspector. Community use of Bowling Club building was also mentioned but it was felt this would be a matter for discussion with the Bowling Club.

A suggestion for recognition of the Members of the Ulnes Walton Action Group for their efforts relating to the fight against the Third Prison was discussed. Enquiries regarding possible options are to be made with Chorley Council.

## 89/25 Litter Picking Contract

The litter picking service provided by Eccleston Parish Council was reviewed. The hourly rate for 2026-27 will increase in line with price indices.

Resolved: the contract is to continue for the 2026-27 financial year.

Lancashire County Council Parish and Town Council Conference - items included Local Government Reorganisation and an update by the Director of Highways and Transport.
